Dear Brothers and Sisters in Christ:

Hallelujah! Greetings in the name of our Lord Jesus Christ! May His abundant grace and blessings be with you all!

Praise and thank our Lord Jesus Christ that the Sacramento Church has been growing in memberships. At the current location, we often experience insufficient space (i.e. classrooms, dining, fellowship, and shower capabilities) for our needs and to host regional events. The Sacramento Church Congregation has approved the process of purchasing a chapel in the city of Sacramento, California. The purchase price is USD\$2,200,000 and required renovation costs are estimated to USD\$1,300,000 (major renovation on kitchen area, restrooms, adding shower facilities, and fencing/gate). The escrow is scheduled to close on January 25, 2025. The Sacramento Church has USD\$450,000 in funds, estimated value of sale of the current building is USD\$1,200,000, and expecting another USD\$360,000 in pledges from the local congregation.

The escrow timeline is described below:

The Sacramento Church will be short of USD\$2,690,000 due to pending sale of current church. The Sacramento Church would like to solicit loans and donations to complete the purchase and renovation.


