Subject: Chapel Construction Update and Funds Solicitation

Dear Brothers and Sisters in Christ:

Hallelujah! Greetings in the name of our Lord Jesus Christ! May His abundant grace and blessings be with you all!

Praise and thanks to our Lord Jesus Christ! The Sacramento Church acquired a new property at the end of January 2025. The property features a chapel with seating for 300–400, multipurpose rooms, classrooms, and offices (16,533 square feet on 0.85 acres).

The congregation has approved a phased renovation totaling USD \$3.5 Million. Phase 1 (near completion) prepares the church for move in and includes asbestos abatement, gates and fencing, electrical and ADA compliance work, flooring, doors and windows, painting, lighting, and walls and bathroom reconfiguration. The total cost of this phase is approximately USD \$1.2 Million, leaving us with \$337,030 in our Construction Fund.


Phase 2 completes the renovation to support ongoing services and future regional/national church events, including the installation of a commercial kitchen, pastors' rooms, classrooms, a library, additional bathrooms and showers, estimated at USD \$2.2 Million.

After Phase 1, and after applying the expected net proceeds from the sale of our current chapel, we are still in need of an additional USD \$912,533 to complete the remaining renovation.
